What we do			
How does ITIC and UMT protect my personal information?	To protect your personal information from unauthorized access and use, we use security measures that comply with federal law. These measures include computer safeguards and secured files and buildings. We will continue to enhance our physical, electronic and procedural safeguards as new technologies become available.		
How does ITIC and UMT collect my personal information?	We collect your personal information, for example, when you: • open an account or apply for insurance • file a claim or provide your mortgage information • show your government issued ID We also collect your personal information from others, such as credit bureaus, affiliates, or other companies.		
Why can't I limit all sharing?	 Federal law gives you the right to limit only sharing for affiliates' everyday business purposes —information about your creditworthiness affiliates from using your information to market to you sharing for nonaffiliates to market to you State laws and individual companies may give you additional rights to limit sharing. 		
Definitions			
Affiliates	 Companies related by common ownership or control. They can be financial and nonfinancial companies. ITIC affiliates include companies with an Investors Title name; financial companies such as Investors Trust Company; and nonfinancial companies such as Investors Title Management Services, Inc. 		
Nonaffiliates	 Companies not related by common ownership or control. They can be financial and nonfinancial companies. ITIC and UMT do not share with nonaffiliates so they can market to you. 		
Joint marketing	A formal agreement between nonaffiliated financial companies that together market financial products or services to you. ITIC and UMT do not jointly market with nonaffiliates.
